1st Item on the Agenda: Petitions from Citizens

2nd Item on the Agenda: Weirton Port Authority Memorandum

Rick Wachtel stated that the Weirton Port requested that he ask the Airport Authority if they would like to participate in the program for federal funding. Rick also passed to each member a Board Resolution for Federal Transit Administration Application. Bob Burkhart made a motion to table this item with Col. Reuss seconded the motion. All were in favor. The motion was carried.

3rd Item on the Agenda: Airport Improvement Projects Update

Bill Walkup reported that Phase 1 of the Noise Study is still being reviewed by FAA. The only other project was the payment to the loan for the Howard T Hangars. That has been requested, received and paid.

4th Item on the Agenda: City and County Budget Reports Review

Bill Walkup reported that this month the City and County have sent their budget request forms for Fiscal Year 2012-2013. The City and County did give the Airport Authority funds to repair some security fencing and to install an electric gate at the Howard hangars. There is funding still available from both the City and County for \$ 12,000.00 each for more internal projects. Bill explained that with budget restraints he did not use the \$ 12,000.00 from each entity. He would like to request the City and County to re-designate those funds for the general account at this time. His suggestion is to request funds City and County for another \$ 12,000.00 and an additional \$ 22,500.00 to make up the deficit from the Air National Guard Joint Use Agreement should the Airport Authority sign the new Agreement. Rodney Woods made a motion to request the \$ 22,500.00 from the City and the County for the next fiscal year with Col. Jim Reuss giving a second. All were in favor. The motion was carried.
